Terms and Conditions

- ➔ By accepting these terms and conditions, you are consenting for us to process your personal data. You also have the “right to be forgotten” which enables you to request the complete deletion of your data.
 - ➔ For morning deliveries Monday to Friday please place your order the previous day via our website or ‘Coldweb’ app.
 - ➔ For same day deliveries please email us or use your online order card via the website or app before 11.30am
 - ➔ All prices are NET and we reserve the right to alter pack size or price as a result of unforeseen market fluctuations and availability. Current prices are available on our website or app. The effective price is that at the time of dispatch. GST or VAT will be charged at the appropriate rate on goods where applicable.
 - ➔ All split cases will be subject to a 25p picking charge per item
 - ➔ The minimum order total for delivery is £50, we reserve the right to add a £5 delivery charge for any orders under this amount.
 - ➔ Shortages must be notified at the time of delivery or to our sales office within 24hours. No credit will be issued until goods are returned to our depot.
 - ➔ Claims for damaged/poor quality/wrongly delivered goods must be notified to Valley Foods Ltd within 24 hours of delivery otherwise they may not be considered. If you wish to return your products to Valley Foods Ltd, the goods must be unused and ‘as new’ condition, in their original box and packaging. You must notify us within 7 working days from date of delivery. It will be your responsibility to return the goods to us at your own cost and risk. If goods are received back ‘as new’ but incomplete with missing components we will charge the cost of the missing components back to you. Goods received back in any condition other than ‘as new’ will be returned back to you, at your cost.
- No Fault Returns – If you have decided to cancel your order or wish to return your products to Valley Foods Ltd we will refund you within 30 days of cancellation or from when we receive the goods, whichever is later. You are responsible for the safe return of the product to us, including the cost of doing so.
- ➔ Accounts are payable by the 28th day following statement date. Interest at 2% per month may be charged on all overdue accounts.
 - ➔ All goods remain the property of Valley Foods Ltd and title on the goods shall not pass until said goods have been paid for in full.
 - ➔ If it is necessary to instruct a lawyer or agent to recover unpaid sums or charges due to Valley Foods Ltd in respect of goods supplied, the purchaser will be liable to pay commissions or fees charged to us by them on recovery of any part of sum due, as a separate debt due to us whether or not they have had to bring the claim to court in order to effect recovery.
 - ➔ Bank charges incurred for whatsoever reason will be added to the appropriate account together with a £25 admin charge per item.
 - ➔ All goods are supplied and subject to the above express provisions and conditions.
